CUSTOMER SERVICE

In 2023, the Detroit Land Bank Authority received **over 67,000 customer inquiries**. In an ongoing attempt to improve our customer service, the DLBA launched a Green Belt project in February 2023. The first phase of the project has been completed and focused on reducing call wait ties and the average days an inquiry remained open. Phase 2 began in January 2024.

Phase 2 will focus on:

- Establishing service level metrics across all DLBA departments for inquiry resolution
- Implementing and monitoring organization wide dashboards for inquiries that incorporate service level agreements.
- Improving customer service delivery with self-service tools
- Assessing proper staffing levels to address inquiry volume

NEXT FIVE STRATEGIC PLANNING

Staff have made significant progress towards our goal of attending at least **100 community engagement events.** DLBA staff engaged with the public at over **20 events in Q2** that included DLBA and City of Detroit hosted events such as:

- Lots of Lots
- Cultivating Create-a-Project (CAP)
- Building Blocks
- Mayor's Charter Mandated meetings
- Various district events
- Block clubs and community groups' meetings

An event calendar can be found on the new **Next Five** new landing page on our website at www.buildingdetroit.org/nextfive/. The calendar provides information on where we will be, and surveys for residents to share their input. The first-round survey has been completed, and a secondary survey will be available soon.

The survey was also distributed through Department of Neighborhood Managers, DLBA social media channels and an email campaign where it was successfully delivered to 6,986 email addresses. By the end of Q2, 104 respondents completed the survey, with residents representing 79.1% of the responses received.



CITYWIDE NEIGHBORHOOD SURVEY

Since September 2023, the Neighborhood Survey Team's (NST) gal with the citywide blight survey is to complete multiple passes of the city to ensure a high degree of accuracy as to the status of blighted property and to monitor the progression of properties over time. The survey team completed their first pass of the city this winter.



CREATE-A-PROJECT

On November 18th, the DLBA hosted its first ever Cultivating Create-a-Project (CAP) event at the Michigan Welcome Center in Southwest Detroit. This event was aimed at Detroit block clubs and community groups interested in purchasing land for neighborhood beautification projects through the Create-a-Project Program. Over 100 people attended with 40 organizations submitting new applications.
